Overview


The Conquip Circular Muck Skip is a traditional crane lift skip used for muck and waste removal. It is fitted with safety catches which are disengaged by hand allowing the skip to self tip and empty automatically.

Key Benefits

- Skip empties automatically in response to the centre of gravity of the bale arm, removing the need for an operator to be in the dangerous discharge zone.
- Large capacity, easy method of transporting muck and waste across sites.



Usage Instructions

Important Usage Notes

- Do not use the Circular Muck Skip for carrying toxic or dangerous materials or chemicals or light fires in or around the skip.
- Do not overfill the skip by volume or weight, the load should be evenly placed.
- At no point during the operation of this skip should personnel be within the discharge zone.
- Releasing of any safety catches must only be performed with the skip resting on the ground and positioned next to the discharge point.
- All of the lifting, tipping and manoeuvring must be carried out by a crane. Do not attempt to move the skip of the bale arm by hand.
- The Circular Muck Skip is for lifting and transporting waste and materials only.
 Do not use to raise or transport personnel.

Usage Instructions


- 1. Attach the lifting apparatus' hook to the skip's bale arm lifting eye. Always ensure that the hook's gate is correctly closed and the lifting eye is seated correctly in the hook.
- 2. If the bale arm is in the lowered position when attaching to the crane, raise the crane to bring the bale arm upright, turn all four safety catches outward and secure with the connected security locking pins.
- 3. Carry out a test lift to familiarise yourself with the locking mechanism.
- 4. Move the skip to the loading point and land the skip on firm level ground, which is able to bear the unit's weight and load.
- 5. Make sure that the bale arm is in the raised position and that all safety catches are set outward.
- 6. Fill the skip evenly, ensuring the load is no wider, longer or higher than the side walls.
- 7. Once loaded and ready, clear all personnel from the area and raise the skip off the ground to check that the load is balanced and secure.
- 8. The skip can now be carefully craned to the discharge area.

- 9. Ensure that no personnel are in the discharge area and lower the skip to the ground.
- 10. Turn one safety catch from each side of the skip inward rear catch for forward tipping, front catch for backward tipping.
- 11. Once the skip is ready to be discharged, clear all personnel from the area and raise the skip to allow it to tip and discharge.
- 12. Having emptied the skip, lower it back to the ground into resting position and lower the bale arm until back into locking position.
- 13. Turn the catches outward to secure the bale arm in the locked position.
- 14. Raise the skip again and manoeuvre to the loading area.
- 15. Once empty and lowered, disconnect the skip from the lifting apparatus.

Safety Instructions

Basic Safety

A site-specific Risk Assessment, and lift plan where applicable, must be completed by the responsible person before using this equipment to control risks, produce a safe system of work and ensure safety for you, your colleagues and others. Your risk assessment will determine the correct Personal Protective Equipment (PPE) for the task you are doing. You must use it. Conquip recommends that you should wear:

- Suitable clothing
- Gloves
- Hard hat
- Protective footwear (steel toecaps)
- Safety glasses











Important Safety Notes

- Read these instructions before using this equipment. If there is anything you do not understand
 or if you have any concerns do not use this equipment. Contact your supervisor or Conquip
 Engineering Group for advice.
- You must check that you have considered all the safety requirements for the task you are doing and that this equipment is suitable.
- You must protect bystanders and the general public by preventing access to the working area.
- Do not use this equipment if you are tired, unwell or under the influence of alcohol or drugs. If you are taking any medicine or undergoing treatment you should inform your supervisor.

Usage & Transportation

- Never unevenly load this equipment.
- The weight of the equipment, together with its attachments, must be added to the weight of the load when calculating the total load that will be imposed on the lifting apparatus / operating machine.
- This equipment must be used in conjunction with the load ratings of the lifting apparatus / operating machine. (Refer to the manufacturers' load ratings and original working instructions).
- Make sure you know how to use this equipment and understand all aspects of its operation in case of emergency.
- This equipment weighs more than 25kg. Do not lift or manhandle without machine assistance.
- Do not operate this equipment near overhead power lines.
- Take care in confined spaces, near ceilings or similar hazards. This equipment was designed for vertical lifting. Do not drag, or swing.
- Before operating this equipment, check that you have enough space for you to work safely and make sure that the working area is clear of hazards, obstructions and personnel.
- Before lowering equipment make sure that the landing zone is clear and capable of accepting the size and weight of the load.
- Crush Risk. Keep hands and feet clear of the equipment at all times to avoid injury.
- Do not exceed the maximum Working Load Limit (WLL) shown on the serial plate. Ensure that the WLL
 on the individual lift points is not exceeded.
- Before lifting, check that the load is secured, balanced and stable. Allow space for the equipment to
 move if the load shifts.

Personnel

- All personnel must wear relevant personal protective equipment.
- Do not wear loose clothing or jewellery and tie back long hair to avoid becoming tangled or trapped in this equipment. You must make everyone in the work area aware of what you are doing.
- All personnel involved in the lifting operation must be competent to do so and must have been briefed in conjunction with this User Guide available from Conquip Engineering Group, the manufacturer.

Equipment Maintenance & Cleaning

- It is mandatory that the equipment is thoroughly examined regularly, by a qualified engineer, to ensure
 compliance with relevant regulation/s. (Conquip recommend to carry out thorough examination every
 six months).
- This product may incorporate various loose and detachable items of lifting gear. Refer to the separate
 requirements for the safe use of those items.
- When not being used, store the unit in a clean, upright condition and in a safe place where it will be
 protected from thieves and unauthorised users.
- This equipment must be inspected by the responsible person before each use and then regularly, as
 determined by your risk assessment or working practice. If you have any concerns about condition or
 suitability do not use.
